



Findings Related to Election Judges in Baltimore City – Primary 2016

35 Republicans were assigned to the Baltimore City Elections Office, not to a polling place. Since there were not enough Rs to work all the polls these Rs should have been assigned to work the polls and not sit in the main office. All MD voters are registered as Democrat, Republican, Unaffiliated, or Other. The “None” (Column K) from their Election Judges document indicate either they are unregistered Judges or Judges who didn’t show up to work. (ii)... a minor who is at least 17 years old and who is too young to be a registered voter may be appointed and serve as an election judge if the minor demonstrates, to the satisfaction of the local board, that the minor meets all of the other qualifications for registration in the county.
If there are more than 6 Judges in a Precinct then there should be no more U or O registered Judges than there are R Judges.
